

The e-Day Licence will replace the current paper day licence for vehicles registered under the Classic, Vintage (Restricted), and Revised Vintage Vehicle Schemes (CVVs) from 1 January 2025.

#### **Effortless Online Purchase:**



Purchase and manage your e-Day Licences seamlessly on LTA's OneMotoring portal—anytime, anywhere.





### Time Savings:

No need to visit LTA to buy paper licences.



#### **Enhanced Convenience:**

Instead of displaying paper licence, you have up to 2359 hours the next day of usage of the CVV to obtain the e-Day Licence.

# TRANSITION TO E-DAY LICENCES FOR CVVS

From 18 December 2024, classic and vintage vehicle owners can start buying or entering the usage date of e-Day Licence through LTA's OneMotoring portal. This early access is to allow the owners time to buy or enter usage date of their e-Day Licence for the use of vehicle from 1 January 2025 onwards.



The 2024 paper day licences can only be used within the calendar year. **Any remaining 2024** paper day licences **cannot be carried forward** to another calendar year.



Starting from 1 January 2025, all paper day licences will no longer be valid for use for Classic and Vintage Vehicles (CVVs). CVV owners must enter their free e-Day Licence usage date (applicable for Classic Vehicles) or buy the e-Day Licence to use the vehicle. The CVV owner can perform these services up to two (2) weeks in advance of the intended usage date.

access. It is available all day
except from midnight to 1am.

<sup>\*</sup>If you miss the deadline to buy or enter usage date of the e-Day Licence, you have 3 more days to declare to LTA and you have to pay a fee of \$30.1 e-Day Licence will be deducted.


You will receive a refund if you cancel an unused paid e-Day Licence before the specified date of use. However, there will be no refund for the cancellation of free e-Day Licence for classic vehicles.

For owners of classic vehicles, you would have to use up your free e-Day Licences before you can buy the additional e-Day Licence(s).

### **ACCESSING DIGITAL SERVICES**

# YOUR GUIDE TO CVV SCHEMES: USAGE AND LIMITS

There are no changes to the usage restrictions for the Classic, Vintage (Restricted) and Revised Vintage Vehicle Scheme. To drive your classic and vintage vehicles, you must buy an e-Day Licence or enter the usage date of your free e-Day Licence (for classic vehicles). Please ensure the classic and vintage vehicles have valid insurance coverage for the intended usage date(s).

#### IMPORTANT REMINDER

It is a serious offence to use the classic and vintage vehicles on the roads without a valid e-Day Licence in force for the vehicle. The culpable driver or registered owner faces a fine not exceeding \$5,000 for a first offence, or not exceeding \$10,000 for subsequent offences.
