

## Apply and Pay Online for ASEAN Goods Vehicle Permit (GVP) Application from 12 March 2023

---

From 12 March 2023, you can pay for your digital GVP and Autopass cards online with your GVP/Autopass card application. There is no change to the GVP application process and the required documents<sup>1</sup>.

Go to LTA's OneMotoring website > Digital Services > Apply for GVP/Autopass Card and complete your GVP/Autopass card application<sup>2</sup> with an additional step to make payment online by VISA or Mastercard Credit/Debit Card, PayPal, Apple Pay or Google Pay.

### **GVP Applications submitted from 12 March 2023 onwards**

You will receive the outcome of your GVP/Autopass card application within 5 working days upon submission of correct documents. Successful applicants no longer need to stop and exit from your goods vehicle to queue at LTA's VEP/Toll office within the land checkpoint to pay for and collect GVP.

- Applicants with existing valid Autopass cards  
Please keep a copy of the LTA's GVP/Autopass approval email in the vehicle and continue to use your existing Autopass card updated with the digital GVP<sup>3</sup>. Present the email and card for enforcement checks upon request by any authorised officer.
- Applicants without Autopass cards  
Please refer to LTA's GVP/Autopass approval email for the steps to collect your Autopass card from our Johor Bahru Service Centres (JBSC)<sup>4</sup> in Malaysia, open 24-hours daily.

### **IMPORTANT NOTE**

**If you have submitted your GVP/Autopass card application before 12 March 2023, please follow the usual steps in the LTA's GVP/Autopass approval email to collect and pay for your GVP/Autopass card at the Woodlands and Tuas Checkpoints' LTA VEP/Toll offices.**

Do top up your Autopass card using the NETS mobile application (available on Apple Store and Google Play Store) and insert the card into the card reader at the immigration booth to register your vehicle's trips into and out of Singapore and pay the requisite fees.
