## PDVL to TDVL Conversion User Guide

#### Things to note:

- 1) You should only refer to this guide if you wish to convert your Private Hire Car Driver's Vocational Licence (PDVL) to a Taxi Driver's Vocational Licence (TDVL).
- 2) If you have recently passed and obtained a temporary PDVL, kindly ensure that your PDVL is issued/ you are able to view your PDVL expiry date in system first before applying for the conversion to TDVL. Otherwise, it will be considered as a fresh TDVL application. You may check your licence expiry date <u>here</u>.
- 3) If your existing PDVL is due to expire, kindly renew your PDVL first before submitting for a conversion to TDVL.
- 4) Please note that the converted TDVL will be valid for the remaining duration of the original PDVL.

**Step 1**: Visit GoBusiness (GB) Portal (<u>www.gobusiness.gov.sg</u>) and login with your SingPass or Login ID.



Step 2: Upon successful login, go to "Licences", and click "Apply Licences".



**Step 3:** Scroll down the list of government agencies and look for "Land Transport Authority". Click on the drop-down list to locate "Apply for Taxi Driver's Vocational Licence (TDVL)". Click "Apply" to proceed.

**Step 7:** Read the General Guidelines for VL Applicants. **\*\*Note that for PDVL to TDVL conversion** application, the application fee is \$28.04. You may disregard the fee listed in the screenshot below. The correct fee will appear at the final payment page. **\*\*** 

### General Guidelines for Vocational Licence (VL) Applicants

- 1. The application fee of \$40 is non-refundable.
- 2. Please do not apply for a vocational licence if:
  - Applicant has a suspended or disqualified driving licence
  - Applicant is an existing vocational licence holder but whose VL is currently suspended or revoked
  - Applicant currently has an on-going investigation case

In general, those who have committed serious offences (including rape, murder or kidnapping) will be barred for life. For less serious offences (including housebreaking and cheating), applications will be barred from consideration for a VL for a certain period after the date of conviction.

3. Applicants are required to pass a medical examination and attend the respective training courses.

4. The application approval is at the sole discretion of LTA.
