NOTES ON INTERBANK GIRO

- 1. Please note that the Applicant and Account Holder need not be the same person. The Applicant refers to the Registered Owner of the vehicle (person/company) who is liable for the renewal of vehicle's road tax. The Account Holder refers to the person/company whose bank account will be used for the GIRO deduction for the payment arrangement with LTA.
- 2. The Applicant ID can be Singapore NRIC for Singaporean/Permanent Resident; Malaysian NRIC for Malaysian; Foreign Passport for Foreigner other than Malaysian; ACRA Registration Number for Company / Business; Unique Entity Number for Statutory / Professional Body / Club / Society / Ministry.
- LTA will inform the registered vehicle owner on the status of the GIRO application (i.e. whether successful or rejected). Please allow approximately 4
 weeks for the processing of the GIRO application.
- 4. The Account Holder(s)' bank will make the necessary deductions from the bank account on LTA's instructions. The deduction will be reflected as "LTA" in the passbook/bank statement.
- 5. About one (1) month before the GIRO deduction date, LTA will send a GIRO Payment Schedule to inform the Applicant of all the pre-requisite(s) that must be met by the stipulated deadline and the GIRO deduction date. Please ensure that all the pre-requisite(s) are met on time and maintain sufficient funds in the bank account for the GIRO deduction to avoid any charges that may be imposed by the bank or by LTA for each failed deduction. Should an unsuccessful deduction occur, the Applicant will receive a notice to renew the road tax by other channels. Late renewal fee will be imposed if a vehicle road tax is renewed after its expiry date.
- 6. Vehicle owners may wish to consider the following before selecting their preferred GIRO deduction date:
