CONSENT FOR HEAVY VEHICLE PARKING AND INDEMNITY TO LTA

I / We agree to fully indemnify the Land Transport Authority of Singapore (“**LTA**”), the Superintendent of Car Parks (as appointed under section 3 of the Parking Places Act 1974) and its members, officers, employees and agents (collectively “**those indemnified**”) from and against all responsibility and liability arising from my / our decision to allow the abovementioned heavy vehicle(s) to park at my / our premises and to hold those indemnified harmless against any and all claims, actions, liabilities, losses, expenses, damages, costs (including and without limitation legal fees on a solicitor-and-client basis), and including any sum paid in settlement thereof, whatsoever incurred or suffered by those indemnified under any cause of action arising out of or in connection with the parking of the abovementioned heavy vehicles. I / We further agree that any dispute(s) that arises shall be handled directly between the registered owner or purchaser of the heavy vehicle(s) specified in the table above and me / us.

I / We hereby acknowledge and agree that any decision made by me / us to permit, authorise, or otherwise allow the abovementioned heavy vehicle(s) to park at my / our premises shall be made entirely at my / our own discretion and risk, and that I / we accept full responsibility for the consequences of allowing such parking, including but not limited to any damage to property, injury to persons. I / We expressly waive any right to bring, commence, or maintain any action, claim, suit, or proceeding of any nature whatsoever against LTA arising from, relating to, or in connection with my / our decision to allow the abovementioned heavy vehicle(s) to park at my / our premises, or arising from, relating to, or in connection with the parking of the abovementioned heavy vehicle(s) at my / our premises.

I / We acknowledge and agree that I / we am / are solely responsible for complying with all applicable laws and regulations relating to the parking of the Heavy Vehicles.
