## **Disposal of vehicles**

We wish to remind all ESAs and motor vehicle dealers on LTA's disposal requirements of vehicles.

Vehicles may be disposed of in 3 ways:

- 1. Scrapped at an LTA-authorised scrapyard;
- 2. Exported out of Singapore; or
- 3. Stored in an LTA-authorised Export Processing Zone (EPZ) pending export.

## 1. Scrapped at an LTA-authorised scrapyard

The vehicle may be sent to any LTA-authorised scrapyard. Once the scrapyard operator accepted the vehicle for scrap, the disposal details will be transmitted electronically to LTA.

2. Exported out of Singapore

The engine block and the full chassis must be exported out of Singapore. Partial export of the engine block or chassis is not allowed. You may refer to Annex A for the details of the export documents to be submitted to LTA. Please note that LTA will not process the export documents if they are found to be non-compliant.

## 3. <u>Stored in an LTA-authorised Export Processing Zone (EPZ)</u>

The vehicle may be sent to any LTA-authorised EPZ for storage pending export. Once the EPZ operator accepted the vehicle for storage, the disposal details will be transmitted electronically to LTA. The maximum storage period is 12 months from the deregistration date of the vehicle. The vehicle (i.e engine block and full chassis) must be scrapped at an LTA-authorised scrapyard or exported out of Singapore with the export documents (see Annex A) submitted to LTA within 14 days from exit of the vehicle from the EPZ or the expiry of the 12-month storage period, whichever is earlier. We wish to highlight that it is an offence to submit or cause to submit false documents. Offenders, if convicted, shall be liable to a fine not exceeding \$5,000 or to imprisonment for a term not exceeding 12 months or to both.

# Annex A – Export documents to be submitted to LTA

The following documents must be submitted to the LTA as proof of export of a vehicle:

- 1. Duly endorsed Cargo Clearance Permit (CCP)\*; and
- 2. Duly endorsed non-negotiable copy of Bill of Lading (BL) that is issued by a shipping line, shipping company or freight agent containing the following details:
  - Exporter / Importer details;
  - Vessel / Voyage number;
  - Port of discharge / destination;
  - Container / seal number (for vehicles stored in container);
  - Engine and chassis numbers of vehicle being exported;
  - Date vehicle is shipped on board the vessel; and
  - Details of all items in the container.

## OR

Malaysian Customs' Import Declaration Form (for **export via Land checkpoints**).

\*Please ensure that the physical engine and chassis numbers of the vehicle is verified by the ICA checkpoint officer and obtain an endorsement on the CCP from the ICA checkpoint officer. No endorsement will be required if the CCP is declared as 'containerised'.
