Enhancement to existing bid enquiry function in the Online Certificate Of Entitlement (OCOE) open bidding system

DID

I refer to the bid enquiry function in the OCOE open bidding system (https://ocoe.lta.gov.sg).

From the <u>first June 2016 COE</u> bidding exercise, a valid Acknowledgement Code (i.e. latest Acknowledgement Code generated by system during bid submission/revision) will be needed for online enquiry on bids submitted in the names of companies. This is in addition to the existing 'Company Bidder ID' mandatory field in the bid enquiry function. To minimise inconvenience to agents/ companies who have multiple bid submissions, only one of the latest valid Acknowledgement Codes is required to proceed with the bid enquiry and view all the submitted bids under one Bidder ID. Please refer to Annex A.

For agents bidding on behalf of companies, please inform your customers accordingly of this change and share the valid Acknowledgement Code with them where necessary.
