DISPLAY OF TAMPER-EVIDENT DECALS ON CHAUFFEUR-DRIVEN PRIVATE HIRE CARS

Referring to an earlier notice Ref:TVLS 01/12/16, we had informed you that all chauffeur-driven private hire cars registered under the class and body codes of Z10/Z11/Z16/Z17 will be required to display a set of serialized tamper-evident decals (decals) by 1 Jul 2017, failing which **it will be an offence under the Road Traffic Act.**

2 For all new chauffeur-driven private hire cars registered/converted on or after 1 March 2017, vehicle owner is required to send these vehicles to Authorized Inspection Centres (AICs) from 17 April 2017 onwards to get the decals affixed if the vehicles are intended to remain as chauffeur-driven private hire cars. Vehicle owner will be required to bear the affixing and decal costs.
