**Adjustment of eNETS Debit Payment Limit for Electronic Bidding of Vehicle Registration Numbers**

The eNETS Debit daily limit for payment of LTA online transactions with several banks has been revised upwards to provide greater convenience to users. Customers of the following banks can login to their Internet Banking Account to increase their maximum daily payment limits as follows.

eNETS Debit (Internet Banking Account)	Maximum Daily Payment Limit	Bank Customer Service Hotline
Citibank	\$10,000	6225 5225
DBS/POSB	\$50,000	1800 111 1111
OCBC/Plus!	\$50,000	1800 363 3333
Standard Chartered Bank	\$100,000	1800 747 7000
UOB	\$50,000	1800 222 2121

With the revised maximum eNETS Debit daily payment limit, the eNETS Debit payment limit for electronic bidding of vehicle registration numbers will be adjusted from the current \$10,000 to \$50,000 with effect from **28 July 2017**.

Thus, for total payable amount (i.e. full bid amount plus service fee with GST):

- i. Up to \$50,000/-, payment must be made via eNETS Debit.
- ii. Above \$50,000/-, payment may be made via eNETS Debit or Cashier's Order. However, the service fee of \$10.70 must be paid via eNETS Debit.

Where payment is by Cashier's Order, the full bid amount must be made payable to Land Transport Authority or LTA. The Cashier's Order must have a validity of at least 3 weeks from the date of bid submission. Bidders will need to print and fold the system-generated self-addressed envelope, enclose the Cashier's Order in the envelope and deposit it into the tender box at LTA, Customer Service Centre, 10 Sin Ming Drive, Level 1, before the closing date and time of the bidding exercise.
