Revised Road Tax Structure for Electric Vehicles from 1 January 2021 – Completion of System Changes

Please refer to our press releases, circulars (Ref: VRL/06/2020 and VRL/08/2020) dated 18 February and 5 March 2020 and the reminder dated 1 December 2020 on the revised road tax structure for electric vehicles (EVs) from 1 January 2021.

2. LTA has completed the necessary system changes to effect the revised road tax rates for existing EVs affected by the revised road tax structure from the policy commencement date (i.e., 1 January 2021). To roll out the system changes, the LTALink system will be **unavailable on 20 December 2020 (Sunday) from 12am to 8am.**

3. From 20 December 2020, existing EV owners will be able to renew their road tax based on the revised rates for the licensing period beyond the policy commencement date (i.e., 1 January 2021).

Excess Road Tax Paid

4. Prior to 20 December 2020, some EV owners may have paid the road tax for the licensing period beyond the policy commencement date (i.e., 1 January 2021) based on the current road tax rates. Any excess road tax paid will be automatically used to offset the road tax payable at the next renewal. If the vehicle is permanently transferred before the next road tax renewal, any excess amount paid will be used to offset the transfer fee payable, and the remaining excess amount paid will be transferred along with the vehicle to the new registered owner.

5. Vehicle owners may check if they had paid excess road tax via www.onemotoring.com.sg (Digital Services > Enquire Road Tax Payable/ Prerequisite(s) To Fulfil) from 20 December 2020.
