## TIGHTENING OF THE PARTICLE NUMBER ("PN") LIMIT FOR GASOLINE DIRECT INJECTION ("GDI") PETROL-DRIVEN VEHICLES

1. From **1 January 2022**, the National Environment Agency will tighten the particle number ("PN") limit for gasoline direct injection ("GDI") petrol-driven vehicles from  $6x10^{12}$  #/km to  $6x10^{11}$  #/km. This measure will apply to cars, taxis and light commercial vehicles ("LCVs")<sup>1</sup> that are registered from 1 January 2022.

2. With the above, existing Vehicle Approval Codes ("VACs") with unregistered GDI petrol-driven vehicles that do <u>not</u> meet the PN limit of  $6x10^{11}$  #/km will be invalidated after **31 December 2021**. As such, all registration applications for cars, taxis and LCVs (with existing VACs) that have been created in the LTALink System but are not submitted before 1 January 2022 (i.e. in 'Save-As-Draft' state) will also be invalidated after **31 December 2021**, if these vehicles do <u>not</u> meet the tightened PN limit of  $6 \times 10^{11}$  #/km.

3. Motor dealers will have to re-submit their applications on Vehicle Inspection and Type Approval System ("VITAS") for the affected vehicles with supporting documents on their emission values (including PN). For such applications involving affected vehicles

undergoing VITAS approval, LTA will waive the pre-registration inspection requirement, subject to the following conditions:

- a. The GDI petrol-driven vehicle had previously passed pre-registration inspection and was issued an inspection acknowledgement letter ("IAL") and a weight certificate ("WC")<sup>2</sup>; and
- b. The IAL and WC must be submitted in VITAS when the motor dealer/importer reapplies for VITAS batch approval<sup>3</sup>.
