Measures to Encourage Prudent Bidding – Increased Bid Deposit and Shortened Validity Period for Category D Temporary Certificates of Entitlement (TCOEs)

To encourage prudent bidding behaviour, with effect from the March 2022 2nd COE bidding exercise¹ onwards, the Category D bid deposit will be increased from \$200 to \$800, and the validity period for Category D TCOEs obtained from the March 2022 2nd COE bidding exercise onwards will be shortened from 6 months to 3 months. Please see LTA's news release of 14 March 2022 (see **Annex**) for details.

Category D TCOEs that have already been obtained before the March 2022 2nd COE bidding exercise will not be affected; that is, the bid deposit remains at \$200 and the TCOE validity period remains at 6 months.

The abovementioned changes do not apply to other COE categories.

Measures to Encourage Prudent Bidding for Category D Certificates of Entitlement (COEs)

Bid Deposit Increased to \$800 and Temporary COE Validity Period Shortened to 3 Months

To encourage prudent bidding behaviour, the Land Transport Authority will adjust the Category D COE bid deposit from \$200 to \$800. The COE bid deposit will only be forfeited if the temporary COE (TCOE) issued to each successful bidder is not used to register a motorcycle before it expires.

- Concurrently, the TCOE validity period will be shortened from 6 months to 3 months. A TCOE, which has not been used to register a motorcycle within 3 months, will be forfeited and returned to the bidding pool in the next COE quarter. This will allow unutilised TCOEs to be returned to the market more quickly.
- 3 The changes will take effect concurrently from the second COE bidding exercise in March 2022 (taking place from 21 to 23 March 2022) and apply to TCOEs obtained from this exercise onwards. The changes are illustrated in the table below:

	Current	With effect from second COE bidding exercise in March 2022 (taking place from 21 to 23 March 2022)
Category D COE Bid Deposit	\$200	\$800
Category D TCOE Validity Period	6 months	3 months

4 Category D TCOEs that have already been obtained before the second COE bidding exercise in March 2022 will not be affected. These changes do not apply to other COE categories.
