BIDDING OF HEAVY GOODS VEHICLE (YR SERIES) REGISTRATION NUMBERS

1. Bids for Heavy Goods Vehicle registration numbers from 1 to 9999 in the <u>YR</u> series will be opened from <u>1.00am on 16 December 2022 (Friday) to</u> <u>4.30pm on 21 December 2022 (Wednesday)</u>.

2. Interested members of the public are invited to submit their bids online through **OneMotoring** website (<u>onemotoring.lta.gov.sg</u>), available from 1.00am to midnight daily during the bidding period. The public can bid for up to three different vehicle registration numbers of the same prefix at the same bid amount in one bid submission, in the order of preference. Only one registration number will be awarded, if successful.

3. Each number in the series will be suffixed with a letter of the English alphabet.

4. The minimum bid amount is \$1,000/-. Offers higher than \$1,000/- shall be in multiples of \$1/-. LTA will be increasing the service fee for bidding with effect from 19 December 2022. Hence, a non-refundable service fee of \$10/- (before GST) is payable through eNETS Debit for each bid submission from 16 to 18 December 2022, and a non-refundable service fee of \$17/- (before GST) is payable through eNETS Debit for each bid submission from 19 to 21 December 2022. For total payable amount (i.e. full bid amount plus service fee with GST):

- i. Up to \$50,000/-, payment must be made via eNETS Debit.
- ii. Above \$50,000/-, payment may be made via eNETS Debit or Cashier's Order.

5. Where payment is by Cashier's Order, the full bid amount must be made payable to **Land Transport Authority** or **LTA**. Bidders are required to print and fold the system-generated self-addressed envelope, enclose the Cashier's Order in the envelope and deposit it into the tender box at LTA, Customer Service Centre, 10 Sin Ming Drive Level 1, before the closing date and time of the bidding exercise.



6. The numbers can only be used for registration of new vehicles or replacement of existing vehicle registration numbers in an individual's or company's name. Successful bidders will not be allowed to transfer the vehicle registration number. Further details on the electronic bidding procedures and the available registration numbers for bidding are available at the **OneMotoring** website (onemotoring.lta.gov.sg).

7. Successful bidders will be notified of the results through email. Bid results will also be available on the **OneMotoring** website online enquiry service (<u>onemotoring.lta.gov.sg</u>) from 12.00pm on <u>28 December 2022 (Wednesday)</u>. Bidders may start using the successful bid number thereafter.
