Introduction of Hybrid Motorcycle Road Tax Framework

From 1 January 2026, the Land Transport Authority (LTA) will introduce a new road tax framework to allow the homologation and registration of hybrid motorcycles¹ in Singapore.

Road Tax Framework for Hybrid Motorcycles

2. The road tax for hybrid motorcycles is calculated based on the higher of either the engine capacity or the electric power rating. The road tax structures for hybrid motorcycles are as follows:

Table 1: Road Tax Structure based on Engine Capacity

| Engine Capacity (EC) | 6-Monthly Road Tax Formula |
|-----------------------------|--|
| Not exceeding 200cc | \$40 x 0.782 |
| Exceeding 200cc but not | $[\$40 + \$0.15(EC - 200)] \times 0.782$ |
| exceeding 1,000cc | |
| Above 1,000cc | $[\$160 + \$0.3(EC - 1,000)] \times 0.782$ |

Table 2: Road Tax Structure based on Power Rating

| Power Rating (PR) | 6-Monthly Road Tax Formula |
|--------------------------|---|
| Not exceeding 10kW | \$40 x 0.782 |
| Exceeding 10kW but not | $[\$40 + \$1.4(PR - 10)] \times 0.782$ |
| exceeding 96kW | |
| Above 96kW | $[\$160 + \$2.4(PR - 96)] \times 0.782$ |

 Table 3: Road Tax Amount Payable

| Road Tax Amount | To find out the road tax of the hybrid motorcycle, calculate road |
|-----------------|---|
| Payable | tax twice: |
| | a) Firstly, using the formula in Table 1 based on the motorcycle's EC, then |
| | b) Secondly, using the formula in Table 2 based on its PR. |
| | The higher of the two amounts will be the road tax amount payable |
| | for the hybrid motorcycle. |

- 3. Other existing registration requirements will continue to apply. These include the need to obtain a Category D Certificate of Entitlement and pay the applicable vehicle taxes/fees such as Registration Fee and tiered Additional Registration Fee (ARF)² for motorcycles.
